# **Qualification Overview**

The Ascentis Level 1 and 2 Award in Environmental Sustainability qualifications are designed to give learners knowledge and understanding of the basic principles of sustainability and environmental impacts. These qualifications introduce the learner to key issues in sustainability, raising awareness of the topic and encouraging them to consider their role in helping to make sustainable choices. The qualifications can be used in an induction programme or integrated with a longer programme of study within a vocational area.

There are several features of this qualification that make it very appropriate for its target learners:

- Assessment and certification can be offered throughout the year, allowing maximum flexibility for centres
- Can be delivered either as a classroom-based course or as a blended learning programme
- Assessments are primarily offered through an online multiple-choice test that will normally be taken at the end of the course.
- There are online resources that can be used alongside the teaching

#### Aims

The aims of these qualifications are to enable learners:

- To understand basic concepts in sustainability
- To develop a basic understanding of the environmental impacts of the creation of goods and services
- To understand what makes up a sustainable community

#### **Target Group**

The qualification is aimed at a range of learners, including:

- Young people wishing to pick up an Award as part of another learning programme
- Young people aged 14 19 who are in various learning environments
